- Reason the ticket was created The field received an unhandled server error message when attempting to apply changes to an Integrated Case (IC) related to householdMemberPayCounty. System corrections were made to resolve the error on the IC.
- Changes the field should expect –The field will only see this error when there is evidence that needs to be corrected, such as relationships between a newborn and birth mother.

# MEDES-147673 IC-CEC EXTENDED ELIGIBILITY-RECEIVED DATE ON GUIDED CHANGE CAUSES MISSING ME CODE

- Reason the ticket was created The CEC EEE created after adding a child to an IC. When two
  different dates were used for the Date Reported and Enter the date on which the person joined
  the household, the CEC EEE created without an ME Code. A validation message was added to
  the guided change to ensure workers enters the Date Reported and Enter the date on which the
  person joined the household to match.
- Changes the field should expect A validation message was added to the Guided Change Add
  a Member screen stating "Date Reported and Date on which this person joined the household
  must be the same date."
